Sealed tenders based on MRS Bi-annual system (District Multan) / approved rates by Non-schedule rate approval committee of PHA for the year 2020-21 are invited from the approved / well reputed Government Contractors of HUD & PHE Department / PHA Multan who got their name enlisted / renewed for the year 2020-21 and have deposited their enlisted / renewal fee for the current financial year. The tender / bidding documents are immediately available after advertisement from the Head Clerk of Deputy Director Engineering, during office hours on written request to Deputy Director Engineering accompanied by:

- Original contractors/ firm's managing partner, authority letter / power of attorney.
- Original CNIC of contractor / firms managing partner.
- Original National Tax Number.
- Original registration with Punjab Revenue Authority.

Or else the tender documents will not be issued. The Earnest Money in the shape of deposit-at-call from any scheduled Bank in the name of Director Admin & Finance PHA Multan must be attached with tender documents otherwise tender will not be entertained.

The tenders will be issued Upto **23-10-2020** from the office of Deputy Director Engineering PHA Multan and will be received on **24-10-2020 from 11:00 AM to 11:30 A.M and will be opened at 12:00 PM** in the office of Director Engineering PHA Multan in the presence of intending contractors / firms or their authorized representatives who like to present. The conditional tenders / telegraphic tenders / tender by post will not be entertained. In case the total tendered amount is less than 5% of the approved estimated (DNIT) amount, the lowest bidder will have to deposit an additional performance security from a scheduled Bank equal to the amount below the estimated cost within 15-days of issuance of notice or within expiry period of the bid, whichever is earlier as required under Finance Department Letter No. Ro(Technical) FD 1-2/83(iv) (P) dated 06-04-2005. All PPRA rules are applicable.
